This agreement is subject to the following conditions:

- Foal registration papers and breeding certificates will not be furnished until the mare owner's account is in good standing
- We must have a signed contract in hand when mare is dropped off at farm
- This breeding contract is good for a period of 24 months

Care and Breeding of Mare:

Mare owner agrees mare is halter broke and easy to lead and/or handle. Mare should also be in healthy and sound breeding condition and be free from infections, contagious or transmissible diseases. The stallion owner reserves the right to request copies of coggins, immunizations, health certificates and/or other records. The stallion owner reserves the right to refuse breeding service to any mare, especially those deemed too dangerous to handle or are in unfit breeding condition.

Farm owner agrees to provide a safe suitable facility for mare/foal while on his property. Mare/foal will have fresh clean water available at all times and an ample supply of good clean hay.



Mares that are brought to the property for live cover may have to be artificially inseminated if the stallion owner has to ship semen on the day the mare is scheduled to be bred naturally. The mare owner will not incur any additional expenses for insemination of the mare.

Mare owner agrees to give the stallion owner suitable amount of time to settle the mare. The mare owner agrees to not remove the mare until the end of the breeding cycle.

Both parties agree that Gary Radish, Farm owner, his agents, family or employees are not liable for death, injuries, sickness, escapes and/or accidents including consequential damages caused to mare/foal. The stallion owner agrees that the mare owner is not liable for death, sickness, injury and/or accidents including consequential damages to the stallion and/or farm owner and handlers.

We strongly recommend, but do not require that the mare be followed closely by palpations and/or ultrasounds including 16-30 days post breeding to verify pregnancy. If the original mare proves to be unbreedable, dies or becomes unfit to breed, delivers a dead foal or aborts, another mare may be substituted by mare owner, if approved by stallion owner. In case of mare or foal death, a death certificate must be provided. If mare aborts or is found to be barren, ultrasound proof and a veterinarian statement must be provided. All information on substitute mare must be provided to stallion owner as requested above on original mare. All provisions of this contract shall apply to any substitute mare.

Live Foal Color Guarantee:

This contract includes a live foal color guarantee. Live foal is defined as a foal that stands and nurses without assistance and is alive 1 year from the last live cover date. For instance, if foal is born on the average due date of 340 days, foal then has 25 days of life guarantee with this contract. Stallion owner must be notified within 14 days of a foal being born dead or dying. If after a mare is pronounced "safe in foal", the mare should miscarry, abort, or prove barren, the mare owner has the privileges to return her within one year from the date of this contract or the loss of the foal. There is no additional stud fee for rebreeds, but mare care does apply. If ever, black, smoky black or smoky cream is produced, mare owner will be refunded entire stud fee, mare care and have return privileges for rebreed at no cost.

Stallion:

Should the stallion die, be sold or become unfit for breeding before any attempt to settle the mare is made, the mare owner will be refunded the stallion breeding fee of \$200. Or mare owner may use paid stallion fee toward another stallion owned by HorseRadish Farm. No refunds will be made for any other reason. Stallion fee's paid are non-transferrable.

Payment of Fee's:

Stud fee must be paid prior to or at time of mare drop off. Mare care and other expenses are to be paid in full when mare is picked up from HorseRadish Farm. We accept cash, personal check or Paypal. If you choose to pay by credit card on PayPal, a 3% processing fee must be paid. A personal check may be made to Gary Radish, owner of HorseRadish Farm. A receipt will be issued to you at time of payment.

This contract represents the entire agreement between the parties. No other agreements, verbal or implied, are included unless specifically stated in this contract or are in writing signed by both parties.
