Ivory's Mountain Magic Shipped Semen Contract

Stud Fee: \$200

Collection/Shipping Container/Shipping Expenses: \$200

Additional Shipments: \$200 each

This agreement is subject to the following conditions:

- Stud and collection/container/shipping fees must be made prior to any semen being shipped
- Foal registration papers and breeding certificates will not be furnished until the mare owner's account is in good standing
- We must have a signed contract in hand prior to any semen being shipped
- This breeding contract is good for a period of 24 months

Breeding Of Mare:

Mare owner acknowledges that the stallion owner strongly recommends that the mare be in the care of a licensed veterinarian or trained qualified breeder prior to and during the insemination process. You will need to work closely with them to make sure your mare has the best possible outcome. The mare should be followed closely by palpations and/or ultrasounds including 18-30 days post insemination to verify pregnancy and to make sure mare does not carry twins. If the original mare proves to be unbreedable, dies or becomes unfit to breed before being pronounced safe in foal, delivers a dead foal or aborts, another mare may be substituted by mare owner. Notification must be made to stallion owner as soon as possible. All provisions of this contract shall apply to any substitute mare. Mare owner must provide all information on any substitute mare as needed above for the original mare.

If a facility is required to monitor ultrasound and/or artificially inseminate your mare, you may drop off your mare at the same facility in Glasgow where the stallion is collected. Their rules and fees will apply.

Shipping/Collection:

Stallion is transported to a Breeding Facility for collection. Normal collection days are Monday, Wednesday and Friday. We will try to honor all special requests. Shipped semen requests will be filled in the order they are received. Mare owner understands that stallion owner may not be able to fill all orders. Mare owner agrees to notify stallion owner as soon as possible of the intent to breed with a preliminary date of needing a semen shipment. When possible the mare owner should give the stallion owner 24 hour notice before the stallion needs to be collected. At very least, we MUST be notified NO LATER THAN



10am EST the day of proposed collection and shipping. All requests for shipped semen will be accommodated to the best of our ability. If enough time is not given or we are unable to collect for any reason, HorseRadish Farm has the right to refuse collection of the stallion. Semen will be shipped overnight the day it is collected via FED EX. If the mare owner provides a business address for overnight shipping, it is guaranteed by the next morning, usually by 10am. It is the mare owner's responsibility to verify shipments will be made by FED EX to the address provided for Saturday delivery. The shipping container used is the Equine Express II, Cooled Semen and Embryo Transport System. This is a disposable container and need not be returned for any reason. HorseRadish Farm will not be held responsible for lost/delayed/damaged semen which is beyond stallion owner's control.

Stallion:

Should the stallion die, be sold or become unfit for breeding before any semen is shipped, the mare owner will be refunded the stallion breeding fee of \$200. Or mare owner may use paid stallion fee toward another stallion owned by HorseRadish Farm. No refunds will be made for any other reason. Stallion fee's paid are non-transferrable. Stallion fee's paid and unused are not refundable. Collection/Shipping Containers/Shipping Fees are non-refundable and non-transferrable.

Payment Of Fee's:

Stud fee and collection/shipping container/shipping costs must be paid prior to any semen shipments being sent out. If additional shipments are required, an additional \$200 per shipment must be made prior to shipments being sent. This fee covers our costs for collection/shipping container/shipping expenses. Payment may be made via HorseRadish Farm site by PayPal. If you choose to pay by credit card on PayPal, you may incur a 6% processing fee. A personal check or money order may be made to Gary Radish, owner of HorseRadish Farm, only if it arrives at HorseRadish Farm a minimum of 14 days prior to needed shipment. Payment by cash may be made at the farm at any time. Semen pickup arrangements may be made at HorseRadish Farm on a collection day. Cost for pickup of semen will include collection and transport container for \$125.00 for each pickup. If at time of pickup, you provide your own container to transport cooled semen, cost will be \$100 for collection, each pickup.

Live Foal Guarantee:

This contract includes a live foal guarantee. Live foal is defined as a foal that stands and nurses without assistance and is alive 1 year from the mare's last date of shipped semen. For instance, if foal is born on the average due date of 340 days, foal then has 25 days of life guarantee with this contract. Stallion owner must be notified within 14 days of a foal being born dead. If after a mare is pronounced "safe in foal", the mare should miscarry, abort, or prove barren, the mare owner has the privileges to rebreed within one year from the date of this contract or the loss of the foal. There is no additional stud fee for rebreeds, but collection/shipping container/shipping expenses will apply. HorseRadish Farm makes no guarantees with semen shipped except that it is the semen of Ivory's Mountain Magic and that at the time of shipment, the semen was inspected under the microscope and was suitable for artificial insemination. This contract represents the entire agreement between the parties. No other agreements, verbal or implied, are included unless specifically stated in this contract or are in writing signed by both parties.
